**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY  
AUTHORIZING THE USE OF THE RECYCLING ENHANCEMENT ACT ("REA")  
GRANT TO FUND CHIPPING OF THE BRUSH PILE**

**WHEREAS**, The Salem County Improvement Authority ("SCIA") administers the REA Grant to help implement and enhance local recycling efforts; and

**WHEREAS**, the brush pile located behind the landfill does not require chipping annually and the last time the pile was chipped was in April 2016; and


**WHEREAS**, the brush pile is now in need of chipping and same has been noted by the DEP; and

**WHEREAS**, estimates were obtained and the lowest responding bidder was Keel-Mar Enterprises of Glen Rock, Pennsylvania with an estimate of \$10,625.00; and

**WHEREAS**, funds are available in the REA Grant accounting line item in the full amount of the cost of the job;

**NOW, THEREFORE, BE IT RESOLVED** that the Recycling Coordinator is authorized to commence work to chip the brush pile.


