RESOLUTION AWARDING CONTRACT FOR SUPPLYING OF DAILY AND INTERMEDIATE COVER MATERIAL TO THE SALEM COUNTY IMPROVEMENT AUTHORITY SOLID WASTE DIVISION

WHEREAS, the Salem County Improvement Authority solicited, received and opened sealed bids on March 26, 2019, at 1:00 pm prevailing time for Supplying of Daily and Intermediate Cover Material to the SCIA Solid Waste Division Landfill; and

WHEREAS, said bids were duly advertised in accordance with Local Public Contracts Law N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, all bid results and recommendations are on file in the Office of the Executive Director for SCIA as required by Law; and

WHEREAS, the Solid Waste Division Manager and SCIA Solicitor have reviewed all bid submissions; and

WHEREAS, the bids were as follows:

Quinton Sand and Gravel, LLC	\$11.50 per ton	

WHEREAS, R&B Debris, LLC was the lowest bidder for the Bid; and

WHEREAS, the SCIA Solicitor noted the Bid Specifications included an incomplete ADA form that did not provide a line for a signature, and neither bidder supplied a signed ADA form; and

WHEREAS, the SCIA Solicitor issued the opinion that the failure to supply a signed ADA form is a waivable defect and can be made a condition of the award of a contract; and

WHEREAS, R&B Debris, LLC submitted a completed but unsigned Statement of Authority form but did otherwise include signatures where required; and

WHEREAS, the SCIA Solicitor has issued the opinion that failure to supply a signed Statement of Authority in the context of the totality of the circumstances constitutes a waivable defect; and

WHEREAS, the SCIA Board has considered the matter and finds the bidder has adequately expressed its intent to be bound by the terms of the bid and therefore exercises its discretion to waive the defect; and

WHEREAS, <u>R&B Debris</u>, <u>LLC</u> did substantially comply with the bid specification in all material respects; and

WHEREAS, in accordance with N.J.A.C. 5:30-5.4, the SCIA Treasurer/Finance Officer has provided a certificate of availability of funds that appropriates funds for this contract to the following line item of the budget #01-05-120-506 Cover Material;

NOW, THEREFORE, BE IT RESOLVED by the Members of the Salem County Improvement Authority as follows:

- 1. The SCIA awards a contract that shall comply with the bid specifications for a total amount of \$146,250.00 (One Hundred Forty-Six Thousand, Two Hundred and Fifty Dollars and Zero Cents), subject to the review and approval of the SCIA Solicitor and the SCIA Risk Manager, to <u>R&B Debris</u>, <u>LLC</u> to Supply Daily and Intermediate Cover for the SCIA Solid Waste Division.
- 2. The Chairman and Executive Director shall be authorized to execute said contract upon compliance by the bidder with the bond and insurance requirements of the specifications.
