RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING A REPAIR TO THE
2005 VOLVO AD25 HAUL TRUCK

WHEREAS, on May 7, 2019, the 2005 Volvo AD25 haul truck suffered a transmission and fuel injectors failure which requires an emergency replacement; and

WHEREAS, a service call was placed to Hoffman Equipment and it was discovered that the transmission and fuel injectors will need replacement; and

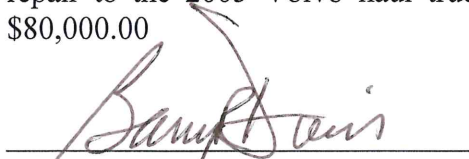
WHEREAS, an estimate was obtained by the Landfill Manager for the above referenced repair and it was determined that the repair cost would be approximately \$79,678.14 based on a visual inspection;

WHEREAS, this equipment is critical for SCIA to be compliant with the NJDEP regulations as to the operation of the landfill. The unit does not have a back-up to cover its use at the site, and it plays a vital role in hauling cover materials on the landfill every day. Covering the landfill daily is required per the SCIA operating permit. The SCIA will be exposed to potential notices of violations and associated fines if it operates out of compliance with its Permit requirements

WHEREAS, the SCIA Emergency Purchase Procedures Policy requires an authorizing Resolution for Hoffman Equipment, the certified Volvo Equipment service dealer for South Jersey, to perform the necessary repairs to the equipment at a cost not to exceed \$80,000.00; and

WHEREAS, funds are available in the SCIA Budget in the not to exceed amount of the \$80,000.00 and same has been certified by the Certifying Financial Officer;

NOW THEREFORE, BE IT RESOLVED by the Salem County Improvement Authority that the Executive Director and Landfill Manager be and the same are authorized to authorize the repair to the 2005 Volvo haul truck transmission in an amount not to exceed the amount of \$80,000.00

On April 7th, 2019 our Volvo AD25 Articulated Dump Truck suffered a transmission failure which requires an emergency replacement. Following a service call on April 7th, it was discovered by a technician from Hoffman Equipment that the in transmission and fuel injectors will need replacement.

The estimated cost to replace the transmission and injectors is estimated to be \$ \$79,678.14 based on a visual inspection. As with the nature of these repairs there is always the possibility of discovering that more parts and labor are required in which case Hoffman Equipment will notify SCIA, before proceeding further.

This equipment is critical for SCIA to be compliant with the NJDPE regulation as to the operation of the landfill. The unit does not have a back-up to cover its use at the site and it plays a vital role in hauling cover materials on the landfill every day. Covering the landfill daily is required per our permit. The NJDEP could issue severe monetary penalties when uncovered landfill areas are observed.

This letter is notification, as required in the SCIA Emergency Purchase Procedures Policy for Hoffman Equipment, the certified Volvo Equipment service dealer for South Jersey, to replace the transmission, fuel injectors and complete the 1000-hour service of the Volvo AD25 Articulated Dump Truck not to exceed \$80,000.00.
