RESOLUTION AUTHORIZING THE AWARD OF A CONTRACT TO PROVIDE LABOR, MATERIAL AND EQUIPMENT NECESSARY FOR CONSTRUCTION AND INSTALLATION OF A GAS COLLECTION SYSTEM EXPANSION

WHEREAS, the Salem County Improvement Authority has a need to acquire the services of a qualified company for the Solid Waste Division pursuant to the provisions of N.J.S.A. 40A:11-1 et. seq. for labor, material and equipment necessary for construction and installation of a gas collection system expansion; and

WHEREAS, the value of these services will exceed \$40,000.00; and

WHEREAS, the Authority advertised for the acceptance of bids and provided specifications for the scope of the work and the requirements of the bid proposals; and

WHEREAS, bids were opened publicly on July 30, 2020; and

WHEREAS, the bidder submitting the lowest responsible bid was Atlantic Lining Company, Inc. of Eastampton, New Jersey in the amount of \$594,219.00; and

WHEREAS, the bid submitted by Atlantic Lining Company, Inc. was within an acceptable financial range of expense anticipated by the Authority and is within the Authority's budgeted appropriation for this project; and

WHEREAS, it is in the best interest of the Authority to award a contract as soon as possible to start the expansion of the gas collection system; and

WHEREAS, in accordance with N.J.A.C. 5:30-5.4, the Chief Financial Officer of the Salem County Improvement Authority has certified in writing that adequate funds for this contract are available from the Authority's capital improvement budget;

NOW THEREFORE, BE IT RESOLVED by the Salem County Improvement Authority Board as follows:

- 1. Atlantic Lining Company, Inc. of Eastampton, New Jersey, is hereby awarded a contract to provide labor, material and equipment for construction of the expansion of the gas collection system.
- These services shall be performed in accordance with the terms and conditions contained in the bid specifications for the project and the attached contract and supplemental documents which are on file in the Office of the Executive Director, including compensation as provided for in such documents.

- 3. The Chairperson and Secretary of the Authority are hereby authorized to execute said contract a copy of which is incorporated herein and made a part of this resolution by reference.
- 4. A notice of the awarding of this contract shall be published in accordance with the Local Public Contracts Law and a copy of this Resolution shall be kept on file with the designated Custodian of Records for the Authority for inspection by the public.
