**A RESOLUTION AWARDED CONTRACT FOR WATER AND WASTEWATER  
FIELD SAMPLING AND ANALYTICAL LABORATORY SERVICES  
UNDER A FAIR AND OPEN PROCESS**

**WHEREAS**, the Salem County Improvement Authority (“SCIA”) pursuant to Resolution 2020-74 adopted on September 10, 2020, authorized the advertisement of Request for Proposals under a Fair and Open Process, pursuant to N.J.S.A. 40A:11-4.1, N.J.S.A. 40A:11—4.3 and N.J.S.A. 19:44A-20 et seq., for Water and Wastewater Field Sampling and Analytical Laboratory Services in Support of Compliance Requirements for Wastewater Discharge Permit, Discharge to Surface Water, Basin Discharge to Groundwater Landfill, and Discharge to Groundwater at the Salem County Solid Waste Facility; and

**WHEREAS**, the said Request for Proposals were opened at the SCIA Solid Waste Office, located at 286 Welchville Road, Alloway, NJ 08001 at 1:00 p.m. on Thursday, October 1, 2020; and

**WHEREAS**, the SCIA received one proposal from ALS Environmental; and

**WHEREAS**, the proposal was reviewed and evaluated and a report has been prepared pursuant to N.J.S.A. 40A:11-4.5; and

**WHEREAS**, the report recommends that a contract be awarded to **ALS Environmental**; and

**WHEREAS**, the SCIA has adequate funds available for such contract as certified by the Finance Officer/Treasurer; and


**WHEREAS**, the SCIA has provided a certificate of availability of funds that appropriates funds for this contract to the following line item of the budget #01-05-120-512, Environmental Monitoring in the amount not to exceed **\$30,000.00** (Thirty Thousand Dollars and Zero Cents);

**NOW THEREFORE, BE IT HEREBY RESOLVED**, by the SCIA as follows:

1. The aforesaid contract is awarded to **ALS Environmental** pursuant to a **Fair and Open Process**; and
2. The Chairman and Secretary are authorized, on behalf of the SCIA, to execute a contract that complies with the terms and requirements of the Request for Proposals and is subject to the preparation, review and approval of the SCIA Solicitor; and

3. A notice of the awarding of this contract shall be published in the official newspaper in accordance with the Local Public Contracts Law and a copy of this Resolution shall be kept on file with the designated Custodian of Records for SCIA for inspection by the public.


