WHEREAS, the New Jersey Department of Environmental Protection ("NJDEP") requires the establishment and filing of a Tariff for the collection of Solid Waste; and


WHEREAS, a Tariff for the Salem County Improvement Authority, Solid Waste Division ("SCIA") had been prepared and adopted on October 27, 2008 and filed with the NJDEP; and


WHEREAS, the SCIA has determined after careful consideration, a need to amend SCIA's Tariff without increasing charges to customers above the peak rate in accordance with the Tariff attached hereto and made a part of this resolution as Exhibit A, said amendments being necessary and in the best interest of the business pursuits of SCIA.

NOW, THEREFORE be it hereby resolved by the Salem County Improvement Authority, as follows:

1. SCIA's Tariff is hereby amended in accordance with the Tariff attached hereto as Exhibit A; and
2. SCIA's Executive Director and Solicitor are hereby authorized and directed to take all actions necessary to file the amended Tariff with the NJDEP in accordance with the applicable regulations.



TERRITORY SERVED

The Salem County Improvement Authority Solid Waste Division is owned and operated by the Salem County Improvement Authority, a Governmental Unit established under the Laws of the State of New Jersey. The Salem County Improvement Authority maintains this project for an orderly program for the disposal of solid waste in order to promote the community welfare, convenience, health and safety, and further establish a County solid waste disposal site and to control solid waste disposal operations therein for the benefit of the residents of Salem County.

The Salem County Improvement Authority Solid Waste Division will accept approved categories of solid waste generated within the areas which have been assigned to the Salem County Improvement Authority Solid Waste Division or otherwise permitted by the latest approved N.J. State Solid Waste Management Plan, for which there are rate schedules provided herein, subject to the standards, terms and conditions contained herein.

The Salem County Improvement Authority Solid Waste Division is located at 286 Welchville Road, Alloway Township, Salem County, New Jersey.

STANDARD TERMS AND CONDITIONS

I. DECLARATION OF POLICY

Pursuant to resolution, it is the intent and purpose of the Salem County Improvement Authority to institute an orderly program for the disposal of refuse in order to promote the community welfare, convenience, health and safety, and to control refuse disposal operations at the Salem County Improvement Authority Solid Waste Division.

II. DEFINITIONS OF WASTE CATEGORIES ACCEPTED AT SCSWD

a. MUNICIPAL SOLID WASTE

HOUSEHOLD, COMMERCIAL AND
INSTITUTIONAL
(NJSWA Class 10)

Waste consisting of household waste from private residences, commercial waste which originates in wholesale retail or service establishments such as restaurants, stores, markets, theaters, hotels and warehouses, and Institutional waste material originating in schools, hospitals, research institutions, public buildings and other waste determined by the Salem County Improvement Authority Solid Waste Division to be shreddable. Laboratory wastes and infectious waste are not included in this category.

b. BULKY WASTE
(NJSWA Class 13)

Large items of waste material such as furniture, including mattresses for disposal.

Also included are items that are recycled, such as appliances (white goods) auto, truck, tractor trailer, heavy equipment tires, computer

equipment and propane tanks.

(NJSWA CLASS 13C)

Waste building materials and rubble resulting from construction, remodeling, repair and demolition operations on houses, commercial buildings, and other structures.

c. VEGETATIVE AND WOOD WASTE
(NJSWA Class 23)

Waste materials from farms, plant nurseries and greenhouses produced from the raising of plants. This waste includes such crop residues as plant stalks, hulls and tree wastes processed through a wood chipper (but not leaves).

(NJSWA Class 23D)

Waste materials that are include brush, tree parts and wood pallets.

d. FOOD AND ANIMAL
PROCESSING WASTES
(NJSWA Class 25)
(NJSWA Class 25A)

Processing food waste materials generated from packing plants, canneries or similar industries.

Processing animal waste materials generated from packing plants, slaughterhouses to include dead animals.

e. NON-CHEMICAL, DRY, NON-
HAZARDOUS, INDUSTRIAL WASTE
(NJSWA Class 27)

(NJSWA Class 27B)

Solid waste materials resulting from the manufacturing industry.

Specifically not included is waste material of a chemical nature which is normally generated by, or used in, chemical petro-chemical, plastic, pharmaceutical, biochemical or microbiological manufacturing processes.

Solid waste materials that consist of slightly contaminated soils.

Specifically contaminated with petroleum hydrocarbons (gasoline or diesel), Contamination level is less than 10,000ppm/TPH.

Items a thru e are defined by New Jersey Department of Environmental Protection, Division of Waste Management as waste identification numbers 10 (Municipal, Household, Commercial and Institutional), 13 and 13C (Bulky Waste), 23 and 23D (Vegetative and Wood Wastes), 25 (Animal and Food Processing Wastes), 27 and 27B (Non-Chemical, Dry-Non Hazardous, Industrial Waste and Oil Contaminated Soil Waste).

WASTE CATEGORIES EXCLUDED

The following wastes are excluded and unacceptable at the Salem County Improvement Authority Solid Waste Division:

DRY SEWAGE SLUDGE
(NJSWA Class 12)

Sludge from a sewage treatment plant which has been digested and dewatered and does not require liquid handling equipment.

DRY HAZARDOUS WASTE
(NJSWA Class 17)

Non-liquid waste materials which pose a present or potential threat to human health, living organism or the environment. Included in this category are waste materials which are toxic, corrosive, irritating or sensitizing, explosive or flammable. Included are dry pesticides and any containers that were used to ship or store hazardous wastes.

DRY NON-HAZARDOUS CHEMICAL
WASTE
(NJSWA Class 18)

Non-liquid material normally generated by or used in chemical, petro-chemical, plastic, pharmaceutical, biochemical or microbiological manufacturing processes that is not included in the dry hazardous waste category.

OIL SPILL CLEAN-UP WASTES
(NJSWA Class 26)

Wastes generated during an oil spill clean-up operation which include, but are not limited to, oil soaked sand and straw, which exceed 10,000ppm/TPH.

INFECTIOUS WASTE
(NJSWA Class 28)

Any waste originating from hospitals, clinics, nursing homes, bio-medical laboratories and other medical facilities which waste has come in contact

with persons having reported communicable diseases as defined in Chapter 11 of the New Jersey State Sanitary Code or any revision thereof.

LIQUID WASTES

WASTE OIL AND SLUDGES
(NJSWA Class 70)

BULK LIQUID AND SEMI-LIQUIDS
(NJSWA Class 72)

SEPTIC TANK CLEAN-OUT WASTES
(NJSWA Class 73)

LIQUID SEWAGE SLUDGE
(NJSWA Class 74)

LIQUID HAZARDOUS WASTE
(NJSWA Class 76)

DEFINITIONS

Automotive crank case drainings and other discarded oils from industrial, aviation and miscellaneous applications including waste oils and materials which are in the form of a highly concentrated slushy residue.

Liquid or a mixture consisting of solid matter suspended in a liquid media which is contained within, or is discharged from, any one vessel, tank or other container which has the capacity of 20 gallons or more. Included are bulk or semi-liquids for which there is not a specific waste category.

Pumpings from septic tanks and cesspools.
Not included are wastes from sewage treatment plants.

Liquid residue from a sewage treatment plant consisting of sewage solids combined with water and dissolved materials.

Free flowing material which poses a present or potential threat to human health, living organisms or the environment. Included in this category are waste materials which are toxic, corrosive, irritating or sensitizing, explosive or flammable. This category shall include liquid pesticides.

LIQUID CHEMICAL WASTE
(NJSWA Class 77)

Free flowing material normally generated by or used in chemical, petro-chemical, plastic, pharmaceutical, biochemical or microbiological manufacturing processes. This material is known to chemically react, hydrolyze, ionize or decompose, is soluble, burns or oxidizes or may react with any of the waste materials which are introduced into the landfill, or produces a foul odor. Not included is any liquid hazardous waste.

HAZARDOUS WASTES
(FEDERAL AND/OR NEW JERSEY
DESIGNATION)

Wastes designated as hazardous by the United States of America, Environmental Protection Agency or the State of New Jersey Department Of Environmental Protection. Any waste of the type defined as "Hazardous Waste" by the U.S. Environmental Protection Agency under Section 3001 of the Resource Conservation And Recovery Act (RCRA) on May 19, 1980; published in the Federal Register, Vol. 45, No. 98, Sections 261.1 through 261.33.

GENERAL

Any material which by nature of its character or quantity is considered detrimental to the efficient and sanitary operation of the Salem County Solid Waste Division.

III. ADMINISTRATION

A. Responsible Agency for operation of Salem County Improvement Authority Solid Waste Division:

The Salem County Improvement Authority (SCIA)

B. Function and Powers

The Salem County Improvement Authority shall establish rules and regulations covering the operation and maintenance of the Salem County Improvement Authority Solid Waste Division.

IV. STANDARDS AND REGULATIONS

1. The Salem County Improvement Authority Solid Waste Division will maintain hours of operation pursuant to the following schedule:

The Salem County Improvement Authority Solid Waste Division will be closed on Sundays and on the following Holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day, and such other days as designated by Law of the act of the Salem County Improvement Authority.

The Salem County Improvement Authority Solid Waste Division shall be open from 7:45am to 12:00pm (noon) on Christmas Eve Day when that falls on a Monday-Friday. Normal business hours of 7:45 am-3:00 pm will be observed when Christmas Eve Day falls on a Saturday.

2. The Salem County Improvement Authority reserves the right to limit or curtail the scheduled hours of operation of the facilities of the Salem County Improvement Authority Solid

Waste Division or close the Facility if such is necessitated in order to comply with the rules and regulations or orders of any governmental authority or if the Salem County Improvement Authority Solid Waste Division authorities deem it necessary in the public interest or to comply with the engineering plans of the Salem County Improvement Authority Solid Waste Division..

3. All customers, persons, companies, corporations, collectors of entities of any kind who use the facilities of the Salem County Improvement Authority Solid Waste Division shall obey all the rules and regulations promulgated by the Salem County Improvement Authority Solid Waste Division. If any person, customer, company, collector, corporation or entity of any kind violates any rules or regulations promulgated by the Salem County Improvement Authority, then the Salem County Improvement Authority Solid Waste Division authorities may exclude them from the facilities.

4. The Salem County Improvement Authority Solid Waste Division shall make and promulgate rules for the safe, adequate and proper conduct of all those who use the facilities of the Salem County Improvement Authority Solid Waste Division. The Salem County Improvement Authority Solid Waste Division reserves the right to exclude from its property any type of material that it deems to be unsuitable for disposal and not authorized for disposal pursuant to this Tariff.

5. The Salem County Improvement Authority reserves the right to exclude from being placed on its facilities any substances or materials, liquid or solid, which the Salem County Improvement Authority Solid Waste Division's authorities deem to be improper by reason of the fact that the said material is dangerous, toxic, flammable, poisonous, explosive, injurious to the public health, welfare or interest or for any other reason deemed to be improper in the sole discretion of the Salem County Improvement Authority Solid Waste Division authorities as provided for in this Tariff.

6. All solid waste delivered to the Salem County Improvement Authority Solid Waste Division for disposal must comply with the Salem County Solid Waste Management Plan ("SCSWMP") with regard to recyclable materials. Recyclable materials as designated by the SCSWMP will not be accepted for disposal.

7. All customers using the facilities of the Salem County Improvement Authority Solid Waste Division shall obey all posted speed limits, all safety rules and follow all directions given

to them by the authorized personnel of the Salem County Improvement Authority Solid Waste Division.

8. The Salem County Improvement Authority Solid Waste Division authorities reserve the right to exclude from its facilities anyone who damages any of the property of the Salem County Improvement Authority Solid Waste Division and may not permit that person, customer, corporation, company or entity to return to the facilities of the Salem County Improvement Authority Solid Waste Division until full restitution is made to cover all damages to the property.

9. All vehicles on the Salem County Improvement Authority Solid Waste Division's premises must be operated by a duly licensed and competent driver not in violation of any of the provisions of Title 39, including, but not limited to narcotics or alcoholic beverages. The determination of whether or not the said driver is in violation of this section shall be within the discretion of the Salem County Improvement Authority Solid Waste Division.

10. In order for any customer whatsoever to use the facilities of the Salem County Improvement Authority Solid Waste Division, its vehicles must be in a safe operating condition and be duly licensed and inspected by all Federal, State, County, Municipal or other governmental authorities having jurisdiction over said vehicles. All vehicles, except private automobiles, which use the facilities of the Salem County Improvement Authority Solid Waste Division shall have the name and address of the operator clearly printed on each said vehicle on a noticeable part of each said vehicle.

11. All vehicles using the Salem County Improvement Authority Solid Waste Division's facilities and premises must be constructed, loaded and operated so as not to cause any spillage or excessive noise of any sort. The following rules shall apply:

- a. The entrance and haul road speed limit shall be fifteen (15) miles per hour.
- b. The Salem County Improvement Authority Solid Waste Division Paved Working Area and Landfill Area speed limit shall be fifteen (15) miles per hour.
- c. Waste shall be deposited only in areas designated by authorities of the Salem County Improvement Authority Solid Waste Division.
- d. Operators of vehicles shall obey the directions of the authorities of the Salem County Improvement Authority Solid Waste Division.
- e. No scavenging shall be permitted on any premises of the Salem County Improvement Authority Solid Waste Division.

- f. Children under 12 years of age and pets must remain in vehicles.
- g. The use of firearms in any disposal site property is prohibited.
- h. Operators of vehicles with crews must have crewmen assist in backing up their vehicles.

12. All spillage must be properly cleaned up by the customer causing same.

13. Vehicles using the access roads to and on the operating site and on the facilities of the Salem County Improvement Authority Solid Waste Division shall assume all risks resulting from the operations conducted thereon, including, but not limited to, tire and suspension damage and shall be of the size and weight that can be safely operated on the operational site and the facilities of the Salem County Improvement Authority Solid Waste Division or on an access road without damage to life, person or property. All vehicles, except private automobiles using the access roads to and on the operating site and on the facilities of the Salem County Improvement Authority Solid Waste Division shall be insured by liability insurance of at least \$300,000.00/\$500,000.00 and \$100,000.00 for property damage. All customers, persons, companies, corporations, collectors or entities of any kind shall, upon request, submit copies of their certificates of insurance reflecting the above coverage.

14. In the event any customer's vehicle becomes inoperable or immovable on the Salem County Improvement Authority Solid Waste Division's facilities or any access road thereto, the Salem County Improvement Authority Solid Waste Division shall have the right to have the vehicle removed at the customer's expense.

15. The Salem County Improvement Authority Solid Waste Division authorities will make every reasonable effort to accept all material properly brought to the operating site of the Salem County Improvement Authority Solid Waste Division. The Salem County Improvement Authority Solid Waste Division authorities reserve the right to refuse any material which exceeds the available capacity of the facility and the equipment, or other conditions, or because of inclement weather which threatens life, person or property on the facilities, operating site or any access roads. The Salem County Improvement Authority Solid Waste Division authorities will make every reasonable effort to keep the access roads under its jurisdiction and the working areas, site locations and facilities of the Salem County Improvement Authority Solid Waste Division in good order, but the Salem County Improvement Authority Solid Waste Division authorities shall not be responsible for any damage done to any customer's vehicles or property

of any kind while the customer is on any access road or working area or site location, or within the facilities of the Salem County Improvement Authority Solid Waste Division.

16. The Salem County Improvement Authority Solid Waste Division reserves the right to refuse access to any person, customer, corporation, partnership or other entity whatsoever who has failed to comply with any provisions of this Tariff, including payment or the terms and conditions until full and complete compliance therewith has been made or assured to the reasonable satisfaction of the Salem County Improvement Authority Solid Waste Division.

17. All rates referenced in this Tariff will be set forth in a schedule of rates and other charges and as determined by the Salem County Improvement Authority Solid Waste Division and are predicated on the labor, equipment, machinery and operating charges in effect at the time, and the Tariff rates may be revised from time to time in the discretion of the Salem County Improvement Authority Solid Waste Division and shall remain in effect until a change thereof is approved by the Salem County Improvement Authority Solid Waste Division and where required by law, by the New Jersey Department of Environmental Protection ("DEP").

18. For all users who are not regular customers of the Salem County Improvement Authority Solid Waste Division, payment shall be by Cash before entrance to the Salem County Improvement Authority Solid Waste Division's facility.

19. All regular users of the Salem County Improvement Authority Solid Waste Division shall have the following payment options.

1. Payment when service rendered in a form generally acceptable in business practice;

2. Two (2) week advance payment for the collector's normal disposal charges at the facility phased over six months in equal payments.

3. A letter of credit, acceptable to the Salem County Improvement Authority Solid Waste Division, in an amount equal to two (2) weeks of the collector's normal disposal charges at the facility.

The collector shall choose from the above options.

20. The Salem County Improvement Authority Solid Waste Division reserves the right to change, for cause, at any time terms for payment or the method of payment for the use of its facilities for solid waste disposal purposes.

21. The terms and conditions as set forth in this Tariff govern all classes of service to the extent applicable unless expressly modified by the terms of specific contracts made with the Salem County Improvement Authority Solid Waste Division.

22. The Salem County Improvement Authority Solid Waste Division reserves the right to change, amend, modify, supplement or delete provisions of this Tariff or any part thereof.

23. The Salem County Improvement Authority reserves the right in its sole discretion to open up for public use any additional areas for sanitary landfill operations which are not presently being used as a sanitary landfill but which are under the ownership of the Salem County Improvement Authority, subject to the necessary governmental approvals. The determination as to what additional areas should be opened for sanitary landfill operations shall be in the sole discretion of the Salem County Improvement Authority.

24. The Salem County Improvement Authority Solid Waste Division authorities reserve the right to curtail the hours of service or to close the Salem County Improvement Authority Waste Facility's facilities due to inclement weather which in the sole discretion of the Salem County Improvement Authority Solid Waste Division authorities makes it impossible to conduct the operations in a safe, adequate and proper manner.

25. The Salem County Improvement Authority and the Salem County Improvement Authority Solid Waste Division authorities shall not be liable in damages to any customer for any act, omission or circumstances occasioned by or in consequences of any acts of God, strikes, lockouts, acts of the public enemy, wars or police actions, blockades, insurrections, riots, epidemics, landslides, lightning, earthquakes, fires, storms, floods, washouts, arrests and restraints of rules and people, civil disturbances, explosions, breakage or accident to machinery, the binding order of any court or governmental authority, and any other cause, whether of the kind herein enumerated or otherwise, not within the sole control of the Salem County Improvement Authority Solid Waste Division, which by exercise of due diligence the Salem County Improvement Authority Solid Waste Division authorities are unable to prevent or overcome, or for any other conduct for which the Salem County Improvement Authority Solid Waste Division may be immune or protected by applicable State or Federal Law.

26. The Salem County Improvement Authority Solid Waste Division may require certifications or test results for any material brought to the Facility. The costs of such certifications and/or tests shall be the sole responsibility of the customer seeking to

deliver the material to the Facility for disposal. The Facility may refuse admittance to any vehicle or customer where the nature of the contents of any such vehicle cannot be readily ascertained and or identified by Facility personnel as permitted at the Facility.

27. All customers, persons, companies, corporations, collectors or entities of any kind desiring to use the facilities of the Salem County Improvement Authority Solid Waste Division for the disposal of acceptable solid waste in a quantity of one (1) or more tons, shall first comply with the following prescribed procedure before admittance to the Salem County Improvement Authority Solid Waste Division.

a. Complete an application for Solid Waste Disposal at the Salem County Improvement Authority Solid Waste Division. Applications will be furnished by the Salem County Improvement Authority. There is to be no payment for the application.

28. The Salem County Improvement Authority provides and maintains scales at the Facility for the purpose of weighing disposal vehicles, loaded and unloaded, to determine the charges for waste disposed of at the Facility on a per ton charge basis in accordance with the following rate schedules. During periods of shutdown or breakdown of scales, the charges for waste disposed of at the Salem County Improvement Authority Solid Waste Division shall be on a per yard basis, in accordance with the Rate Schedules. Measurement of waste, when the scales are not in use, shall be on a per vehicle capacity basis or as otherwise measured by the Salem County Improvement Authority Solid Waste Division.

29. Where more than one (1) Rate Schedule is available to particular customers, the Solid Waste Facility shall have at all times the duty to assist such customers in the selection of the Rate Schedule most favorable for their individual requirements and to make every reasonable effort to insure that such customers are served under the most advantageous schedule.

30. The Salem County Improvement Authority Solid Waste Division hereby adopts the Regulations for Solid Waste Disposal Utilities of the State of New Jersey as promulgated by the DEP at N.J.A.C. 7: 26H-4.3 and 4.7, which regulations are incorporated herein by reference thereto.

31. Payment will be due within thirty (30) days of the invoice date for all customer classes. For each invoice paid after the thirty (30) day period, Salem County Improvement

Authority Solid Waste Division will charge, and the Customer will pay, the non-contract rate for the invoice more than forty five (45) days late together with a late fee in the amount of one and one-half percent (1.5%) per month. Additionally, SCIA will assess a \$50.00 late fee for any returned check.

32. The Salem County Improvement Authority Solid Waste Division may assess or charge customers and users of the Facility miscellaneous fees and surcharges as specified from time to time in the schedule of rates for the Facility including: (a) afterhours surcharge, (b) credit card processing fee, (c) overweight surcharge, (d) recyclable material in solid waste load surcharge, (e) handling fees for special waste, (f) weighing load charge and a minimum fee. In addition, the Salem County Improvement Authority Solid Waste Division may offer reduction in solid waste disposal rates for high volume users of the Facility in accordance with the terms and conditions specified in the schedule of rates approved from time to time by the Salem County Improvement Authority Solid Waste Division.

33. Through 100 . . . , reserved for future use.

V. RATE SCHEDULES

RATE SCHEDULE NO. 1

MUNICIPAL SOLID WASTE, HOUSEHOLD, COMMERCIAL AND INSTITUTIONAL (NJSWA Class 10) and VEGETATIVE WASTE (NJSWA Class 23 and 23D); collected by municipal or municipally contracted and private solid waste collectors shall be accepted for disposal of a rate up to \$130.00 per ton. When scales are inoperable, the charge shall be calculated per cubic yard at the current tipping fee rate.

RATE SCHEDULE NO. 2

BULKY WASTE & TREES (NJSWA Class 13 and 13C); collected by municipal or municipally contracted and private solid waste collectors shall be accepted for disposal of a rate up to \$130.00 per ton. When scales are inoperable, the charge shall be calculated per cubic yard at the current tipping fee rate.

Definition of Units and Measure:

RATE SCHEDULE NO. 3

FOOD AND ANIMAL PROCESSING WASTES (NJSWA Class 25 and 25A) and NON-CHEMICAL, DRY-NON HAZARDOUS, INDUSTRIAL AND OIL CONTAMINATED SOIL WASTES (NJSWA Class 27 AND 27B) and other materials deemed by the SCSWD Superintendent to be unwieldy or require special handling shall be accepted for disposal of a rate up to \$130.00 per ton. When the scales are inoperable, such wastes shall be accepted and calculated per cubic yard at the current tipping fee rate.

RATE SCHEDULE NO. 4

Rates for various classes of vehicles containing household solid waste, garbage, commercial waste, bulky refuse, ashes, institutional wastes, rubbish and street refuse originating in Salem County originating at the disposer's residence, farm or place of business and hauled to the Solid Waste Division in the disposer's owned or leased vehicle, shall be as follows:
