**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING THE AWARD OF A CONTRACT
PURSUANT TO A FAIR AND OPEN PROCESS TO PROVIDE FOR
A PROFESSIONAL ENGINEER FOR TITLE V AIR COMPLIANCE**

WHEREAS, the Salem County Improvement Authority has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of *N.J.S.A.* 19:44A-20.4, *et seq.*; and

WHEREAS, *N.J.S.A.* 19:44A-20.5 provides that contracts awarded through a fair and open process may be awarded based on price and other factors; and

WHEREAS, the Salem County Improvement Authority has a need to acquire the services of a Professional Engineer for Title V Compliance as a fair and open contract pursuant to the provisions of *N.J.S.A.* 19:44A-20.5; and

WHEREAS, the Executive Director has determined and certified in writing that the value of these services will likely exceed \$17,500.00; and

WHEREAS, on or before February 11, 2021, SCS Engineers, submitted a responsive and responsible proposal, price and other factors considered, to provide professional engineering services for the Solid Waste Division, Salem County Improvement Authority; and


WHEREAS, funding for this contract shall be encumbered by the Salem County Improvement Authority Treasurer/Finance Officer in accordance with *N.J.A.C.* 5:30-5.4;

NOW, THEREFORE, BE IT RESOLVED by the Salem County Improvement Authority Board as follows:

1. SCS Engineers, Medford, New Jersey, is hereby awarded a contract, pursuant to a fair and open process, to provide Professional Engineering Services with regard to Title V Air Compliance for the Salem County Improvement Authority, commencing February 12, 2021, and terminating February 10, 2022, which services shall be performed in accordance with the terms and conditions contained in the attached supplemental documents which are on file in the Office of the Executive Director, including compensation as provided for in such contract.
2. The Chairperson and Secretary of the Authority are hereby authorized to execute said contract.

3. A notice of the awarding of this contract shall be published in accordance with the Local Public Contracts Law and a copy of this Resolution shall be kept on file with the designated Custodian of Records for the Authority for inspection by the public.


