RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY AUTHORIZING THE PURCHASE OF A LANDFILL GAS ANALYZER

WHEREAS, The Salem County Improvement Authority ("SCIA") has a need to purchase a landfill gas analyzer to control the methane gas; and

WHEREAS, Landfill Manager Lodie van Tonder sought quotes from distributers who sell and supply landfill gas analyzers of the type that would meet SCIA's needs; and

WHEREAS, it was determined that Elkins Earthworks, LLC, provided the lowest responsive quote for the type of landfill gas analyzer required by SCIA for use in its landfill, specifically an Envision Gas Analyzer for the sum of \$12,895.48, said quote being attached hereto as Exhibit A; and

WHEREAS, the cost of the Envision Gas Analyzer is below SCIA's bid threshold and thus is not subject to the requirements of public bids under the New Jersey Local Public Contracts Law; and

WHEREAS, funds are available in the full amount of the purchase price of the landfill gas analyzer and same have been certified by the Certifying Financial Officer;
