As per Lodie van Tonder, Landfill Manager's request, I would like to echo that request to promote Joseph LeDrew from full-time laborer to full-time equipment operator for a 90-day trial period.

SCIA hired Joseph LeDrew on October 1, 2020 as a seasonal laborer upon the resignation of two summer interns. Effective on January 4, 2021 Joseph's position went to fulltime laborer at an hourly rate of \$13.00 and after Joseph is scalemaster certified, his hourly rate will increase to \$14.00 per hour.

Because of NJ Weights and Measures backlog and waiting for them to schedule a certification test, Joseph has yet to attain his scalemaster certification.

I am proposing to increase Joseph LeDrew's hourly rate to \$17.00 after the 90-day trial period, August 13, 2021. Joseph will only be promoted to this position should he obtain his CDL by September 1, 2021, which is giving him three months of studying for his CDL and training provided by staff here on our site.

Joseph is a hardworking and conscientious individual, who has been an asset to our team. He is proficient in the skills of a laborer, i.e, grass cutting, weed whacking, weed pulling, ditch clearing, and litter pickup. With Lodie's training and guidance, he will also be able to be trained on the gas analyzer instrumentation.
