## RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY AUTHORIZING AWARD OF A BID FOR REPLACEMENT OF THE LANDFILL FLARE CONTROL PANEL TO PARNEL BIOGAS, INC.

WHEREAS, The Salem County Improvement Authority ("SCIA") has a need for replacement of the landfill flare control panel; and

WHEREAS, SCIA publically advertised for the acceptance of open public bids and provided specifications for the scope of the work and the requirements of the bid proposals, pursuant to N.J.S.A. 40A:11-4; and

WHEREAS, bids were opened publicly on July 1, 2021; and

WHEREAS, the bidder submitting the lowest responsible bid was Parnel Biogas, Inc., of Glenpool, Oklahoma in the amount of \$63,446.00, representing a bid of \$34,621.00 for the Flare Control Panel and \$28,825.00 for the Motor Starter Control Panel, a copy of which is attached and made a part of this Resolution as Exhibit A; and

WHEREAS, the bid submitted by Parnel Biogas, Inc. was within an acceptable financial range of expense anticipated by SCIA and is within the SCIA's budgeted appropriation for this project; and

**WHEREAS**, funds are available in the Landfill Gas Flare accounting line item in the full amount of the cost of the replacement and same have been certified by the Certifying Officer;
