RESOLUTION REJECTING ALL BIDS RECEIVED IN RESPONSE TO THE REQUEST FOR BIDS FOR INSTALLLATION OF THE LANDFILL FLARE CONTROL PANEL AND AUTHORIZING RE-BIDDING

WHEREAS, the Salem County Improvement Authority has a need to acquire the services of a qualified contractor for installation of the Landfill Flare Control Panel; and

WHEREAS, the Authority publicly advertised, pursuant to the Open Public Contracts Law, N.J.S.A. 40A:11-1 et seq. and provided specifications for the scope of the work and the requirements of the bid proposals for a public bid opening that occurred on October 7, 2021; and

WHEREAS, bids were opened publicly on October 7, 2021, and the bidder submitting the lowest and only bid was from Atlantic Lining Company in the amount of \$645,300.00; and

WHEREAS, the sole bid substantially exceeds the cost estimates for the goods and services as prepared by SCS Engineers on behalf of SCIA and substantially exceeds SCIA's appropriation for the goods and services; and

WHEREAS, the Authority has determined after a review of the sole bid submitted and upon the advice of the Authority solicitor, the Authority may reject all bids and re-bid the project in accordance with N.J.S.A. 40A:11-13.2(a) and (b).

NOW THEREFORE, BE IT RESOLVED by the Salem County Improvement Authority Board as follows:

- 1. All bids opened on October 7, 2021, to install the landfill flare control panel are hereby rejected in accordance with N.J.S.A. 40A:11-13.2(a) and (b); and
- 2. The Executive Director and/or Authority Engineer are hereby authorized to proceed to re-bid the project and to publicly advertise in accordance with the Open Public Contracts Law, N.J.S.A. 40A:11-1 et seq., the solicitation of bids for the installation of the Landfill Flare Control Panel.
