**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY  
AUTHORIZING THE AWARD OF A CONTRACT PURSUANT TO A FAIR AND OPEN  
PROCESS TO PROVIDE FOR A PROFESSIONAL ENGINEER FOR  
TOPOGRAPHICAL ENGINEERING**

**WHEREAS**, the Salem County Improvement Authority has determined that it shall use a fair and open process to acquire certain services in accordance with the provisions of *N.J.S.A. 19:44A-20.4, et seq.*; and

**WHEREAS**, *N.J.S.A. 19:44A-20.5* provides that contracts awarded through a fair and open process may be awarded based on price and other factors; and

**WHEREAS**, the Salem County Improvement Authority has a need to acquire the services of a Professional Engineer for the Annual Topographical Survey for the Solid Waste Division as a fair and open contract pursuant to the provisions of *N.J.S.A. 19:44A-20.5*; and

**WHEREAS**, the Executive Director has determined and certified in writing that the value of these services will likely exceed \$17,500.00; and

**WHEREAS**, on or before February 10, 2022, Alaimo Group submitted a responsive and responsible proposal, price and other factors considered, to provide professional engineering services for the Annual Topographical Survey for the Salem County Improvement Authority; and

**WHEREAS**, funding for this contract shall be encumbered by the Salem County Improvement Authority Treasurer/Finance Officer in accordance with *N.J.A.C. 5:30-5.4*;

**NOW, THEREFORE, BE IT RESOLVED** by the Salem County Improvement Authority Board as follows:

1. Alaimo Group of Mount Holly, New Jersey, is hereby awarded a contract, pursuant to a fair and open process, to provide Professional Engineering Services for the Annual Topographical Survey for the Salem County Improvement Authority, commencing February 11, 2022, and terminating February 9, 2023, which services shall be performed in accordance with the terms and conditions contained in the attached supplemental documents which are on file in the Office of the Executive Director, including compensation as provided for in such contract.
2. The awarding of this contract is contingent upon Cornerstone Engineering submitting a Certificate of Good Standing as proof that no members of Cornerstone have ever had their license suspended or revoked in New Jersey or any other state.

3. The Chairperson and Secretary of the Authority are hereby authorized to execute said contract.
4. A notice of the awarding of this contract shall be published in accordance with the Local Public Contracts Law and a copy of this Resolution shall be kept on file with the designated Custodian of Records for the Authority for inspection by the public.


