Dear Julie:

As you know, the Salem County Improvement Authority plans to remove and replace their outbound scale and concrete approaches. In addition, site work associated with resurfacing of the paved road; and regrading of the lawn area adjacent to the road is necessary to improve poor drainage conditions. Since a large portion of the cost of the project is the replacement of the scale, separate contracts for scale replacement and site work may be more economical than one contract.

SCOPE OF SERVICES

We propose the following scope of services:

Design and Bid Phase

- 1. <u>Field Survey</u>: Due to the need to improve poor drainage conditions, a field survey is recommended.
- 2. <u>Plans</u>: Plans for the scale replacement and associated site work would be prepared.
- 3. <u>Specifications</u>: Separate specifications and contract documents for the scale replacement contract and site work contract would be prepared.
- 4. Engineer's Estimates: Cost estimates for each contract would be provided.
- 5. <u>Bid Phase Services</u>: Including receipt of bids and recommendation for award of each contract.

- Consulting Engineers -

Construction Phase

- 6. Construction management, consisting of pre-construction meetings, review of submittals, and estimates for payment.
- 7. Limited field inspection.
- 8. Punch list preparation and contract closeout.

The budget for our office to perform the work outlined above is estimated at \$20,000 for Design and Bid Phase services; and \$20,000 for Construction Phase services, for a total of \$40,000. We would not exceed this amount unless authorized by Salem County Improvement Authority.
