#### GRINDING SERVICES AT THE SALEM COUNTY LANDFILL

# **Project Description**

Grinding and vegetative debris pile at the landfill in Salem County NJ.

# **Project Scope**

The scope consists of the mobilization of the necessary equipment and manpower to grind the vegetative debris. Only the piles that consist of Stumps, wood and brush will be processed and removed. Dirt, soil, rocks, and non organic material will not be processed or removed.

Grinding spoils are to remain on site.

Pricing is based on one mobilization to the site. Standard wage rates, and non-union job site. Assumptions, exclusions, and inclusions are listed below. Additional mobilizations will be billed at the contract rate stated below in the pricing section. A minimum two week notice is required for mobilization

### A. Assumptions

- 1. Grinding is to be done by mechanized equipment.
- 2. Free and clear access to work areas
- 3. Full access to the site would be provided.
- 4. Continuous work flow

#### B. Inclusions

- 1. One mobilization to the job site
- 2. Standard wage rates, open shop, non-union
- 3. All grinding spoils will be remain.

#### C. Exclusions

- 1. Installation and maintenance of E&S controls
- Installation of construction entrances



- Surveying and layout
   Location of utilities
- 5. Traffic control.
- 6. Performance and payment bonds
- 7. Handling of hazardous waste
- 8. Removal and handling of stumps in contaminated areas
- 9. Removal of unforeseen underground structures or trash
- 10. Wet Land Permits

#### **Total Contract Value**

The cost for the grinding would be time and material, billable as follows

Mobilization/demobilize

\$4,000.00

Cost per for 1,100 hp Person Horizontal grinder, 1 Excavators with Rotobeck grapple, operators, fuels and lubricants would be \$14,000.00

Additional mobilizations beyond the one in the base contract, would be charged out at a cost of \$5,500 per mobilization.

Contract subject to the Strobert Tree Services terms and Conditions.

Payment is due upon completion. No Retainage.
