The question was asked at the last board meeting regarding average price per ton, it was down due to oil contaminated soil tonnage

Landfill revenue decreased in September, average price per ton down, Hurricane Ian dropped 6.2" of rain (which will be reflected on next month's report), leachate hauling and treatment expense is down; in 9 months SCIA has not purchased any cover material, beneficial use soil income is down
