**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY  
RESCINDING RESOLUTION 2022-07 AND AUTHORIZING THE PURCHASE OF A PICK-UP  
TRUCK THROUGH A STATE CONTRACT IN ACCORDANCE WITH N.J.S.A. 40A:11-12**

**WHEREAS**, The Salem County Improvement Authority ("SCIA") authorized the purchase of a 2022 Ford F150 Responder in an amount not to exceed \$40,000 in accordance with Resolution 2022-07 on January 13, 2022; however, the Landfill Manager has been notified that the order has been canceled; and

**WHEREAS**, due to the cancelation of that order, Resolution 2022-07 is hereby rescinded; and

**WHEREAS**, a 2023 Ford F150 pick-up truck can be ordered at an increase in the price of \$8,602.00, which results in a purchase price not to exceed fifty thousand (\$50,000.00) dollars; and

**WHEREAS**, SCIA will purchase the pick-up truck through a State Contract in accordance with the provisions of N.J.S.A. 40A:11-12; and

**WHEREAS**, funds are available in the full amount of the purchase price of the pick-up truck and same have been certified by the Certifying Financial Officer:

**RE:** Request to Purchase a Pickup Truck

I respectfully request approval to purchase a 2022 Ford F150 under state contract #20-FLEET-01189 for the sum of \$38,046 as a capital equipment purchase for 2022. The truck will need to be ordered no later than 1-14-22 and will take approximately 32 weeks (8 months) for delivery.

The purchase of this truck is needed to replace our 2004 Ford F350 that is used on the landfill and has significant problems requiring replacement of the 18-year-old truck. The intent is that once we take delivery of the new unit is to pass down my truck to landfill operations and therefore utilize the new truck for landfill management. This will also help with being more cost efficient as the new truck will be a V6 and will get almost twice the fuel mileage that I am currently getting with a V8.
