**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY  
AUTHORIZING ACCEPTANCE OF A QUOTE FOR FENCING**

**WHEREAS**, the Salem County Improvement Authority (“SCIA”) is seeking methods for controlling the number of animals traversing or gaining access to the retention basin area; and

**WHEREAS**, in an effort to control the animals traversing the area around the retention basin, and in furtherance of SCIA’s efforts to control the presence of fecal coliform at the landfill, it is advisable to install fencing; and

**WHEREAS**, Landfill Manager, Parker Smith conducted due diligence by investigating the appropriate fencing type and seeking quotes from a number of fencing companies; and

**WHEREAS**, Landfill Manager, Parker Smith obtained a minimum of three (3) quotes from fencing companies capable of providing and installing the required fencing; and

**WHEREAS**, Endevers Fence, LLC (“Endevers”) provided the lowest responsible quote for the appropriate type of fencing for this need as contained in the estimate attached hereto as Exhibit A; and


**WHEREAS**, in no event will the cost the fence exceed \$41,353 in accordance with the attached estimate; and


**WHEREAS**, Endever has filed the required campaign contribution disclosure forms under the Pay to Play laws of the State of New Jersey with SCIA and Endever being eligible thereunder for the award of the contract; and

**WHEREAS**, funds are available in the full amount of the purchase price of the fencing and same have been certified by the Certifying Financial Officer:

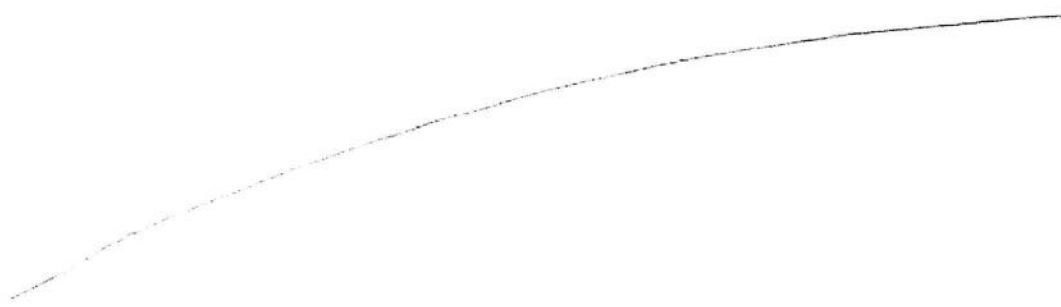
