**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING THE RENTAL OF A GRINDER FOR ONE MONTH**

WHEREAS, The Salem County Improvement Authority ("SCIA") was provided a demonstration by GT Mid Atlantic, LLC ("GT"), of a grinder, Tana 440DT, to reduce the volume of the material going into the landfill which will aid in compaction and reduce the space taken up by the material in the landfill; and

WHEREAS, SCIA is considering purchasing the grinder; however, the Landfill Manager has determined that it would be beneficial to SCIA if the grinder could be used for a longer period of time to determine if increased compaction goal can be reached and if the purchasing of a grinder would be beneficial and in the best interest of SCIA; and

WHEREAS, the Landfill Manager completed his due diligence by calling other companies to inquire about similar grinder machines, including the Foley Caterpillar dealer and JESCO, and he was unable to get an estimate for comparable equipment; and

WHEREAS, the cost of the rental of the Tana 440DT grinder from "GT" is \$35,000 per month; and

WHEREAS, SCIA has determined that the cost of the rental of the Tana 440DT grinder will exceed the sum of \$17,500.00, but be less than \$44,000.00, (SCIA's bid threshold amount) and therefore requires Board approval for this expense; and

WHEREAS, this contract is being awarded under a Non-Fair and Open Process, with "GT" having filed the required campaign contribution disclosure forms under the Pay to Play laws of the State of New Jersey with SCIA and "GT" being eligible thereunder for the award of the contract; and

WHEREAS, funds are available in the Equipment Purchases (61-00-000-200) accounting line item for the rental cost of \$35,000 for one month;

NOW, THEREFORE, BE IT RESOLVED that the Chairman and Secretary are authorized, on behalf of SCIA, to execute a contract with "GT" for a one month rental of a Tana 440DT grinder at a cost of \$35,000.00, subject to the preparation, review and/or approval of the SCIA Solicitor.




