**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING THE USE OF THE CLEAN COMMUNITIES GRANT TO FUND THE
PURCHASE OF THREE (3) LITTER GUARD FENCES**

WHEREAS, The Salem County Improvement Authority ("SCIA") administers the Clean Communities Grant which funds efforts to control litter; and

WHEREAS, as solid waste is being dumped at the landfill it tends to blow around causing litter; and

WHEREAS, litter guard fencing will stop the litter from leaving the working face of the landfill and will make gathering up of litter more efficient; and

WHEREAS, SCIA has determined that the cost of the litter guard fencing is below SCIA's bid threshold; and

WHEREAS, quotes were obtained and the lowest responsive quote was from Metta Technologies, Inc. ("Metta") of Jackson, Michigan with an amount of \$26,430.00, a copy of which is attached hereto and made a part of this Resolution as Exhibit A; and

WHEREAS, Metta has filed the required campaign contribution disclosure forms with SCIA and Metta being eligible thereunder for the award of the contract; and

WHEREAS, funds are available in the Clean Communities Grant accounting line item in the full amount of the cost of the job;

WHEREAS, funds are available in the full amount of the cost of three litter fences and same have been certified by the Certifying Financial Officer;




