# RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY AUTHORIZING THE PURCHASE OF A KUBOTA ZD1211L-3-72 DIESEL ZERO TURN MOWER OVER \$10,000

WHEREAS, SCIA Policy requires that expenditures over \$10,000 be approved by the Board and this purchase has been quoted in the amount of \$14,856.00 (17,856.00 minus a trade-in credit of \$3,000.00); and

WHEREAS, this contract is not subject to the New Jersey Pay to Play Law and is below SCIA's bid threshold; and

WHEREAS, funds are available in the full amount of the purchase price of the mower and same have been certified by the Certifying Financial Officer; and
