**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY**  
**AUTHORIZING AWARD OF BID FOR A 2011 OR**  
**NEWER ROLL-OFF TRUCK**

**WHEREAS**, The Salem County Improvement Authority ("SCIA") has a need to purchase a roll-off truck to move the 40-yard containers from the Convenience Center to the working face of the landfill, transport tires and recyclables to an end market business and to otherwise save the cost of using a private hauler; and

**WHEREAS**, Landfill Manager Parker Smith and other SCIA employees knowledgeable in the purchasing of the roll off truck conducted due diligence regarding the year and type of roll-off truck needed by SCIA; and

**WHEREAS**, Resolution 2023-78 SCIA authorized publicly advertised for the acceptance of open public bids and provided specifications for the scope of the work and the requirements of the bid proposals, pursuant to N.J.S.A. 40A:11-4; and

**WHEREAS**, bids were opened publicly on September 7, 2023; and

**WHEREAS**, the bidder submitting the lowest responsible bid was Redoak Disposal Co. 138 Bridgeton Road, Elmer, NJ 08318 in the amount of \$75,000.00 (Seventy five thousand dollars); and

**WHEREAS**, the bid submitted by Redoak Disposal Co. was within an acceptable financial range of expense anticipated by SCIA and is within the SCIA's budgeted appropriation for this project; and

**WHEREAS**, funds are available in the Equipment (Capital) accounting line item in the full amount and same have been certified by the Certifying Officer;
