**RESOLUTION OF THE SALEM COUNTY IMPROVEMENT AUTHORITY
AUTHORIZING AWARD FOR SUPPLY AND INSTALLATION OF A NEW BATEMAN
DMG200 MAGNET GRAPPLE OR EQUIVALENT**

WHEREAS, The Salem County Improvement Authority ("SCIA") has a need to purchase a magnet grapple attachment for its excavator to aid and assist in sorting recyclables and other materials during the loading of C&D waste into its shredder. This will allow for better and more precise loading, while capturing a higher percentage of recyclable material; and

WHEREAS, Landfill Manager Parker Smith and other SCIA employees knowledgeable in the purchasing of the magnet grapple conducted due diligence regarding the type of magnet grapple needed by SCIA; and

WHEREAS, Resolution 2023-87 dated September 14, 2023 SCIA authorized the advertisement of open public bids and provided specifications for the scope of the work and the requirements of the bid proposals, pursuant to N.J.S.A. 40A:11-4; and

WHEREAS, bids were opened publicly on October 11, 2023 and the lowest responsible bid was submitted by Groff Tractor Mid Atlantic, 551 N. Harding Highway, Vineland, New Jersey, a copy of which is attached hereto and made a part of this resolution as Exhibit A; and

WHEREAS, the bid submitted by GT Mid Atlantic, is within an acceptable financial range of expense anticipated by SCIA and is within the SCIA's budgeted appropriation for this equipment; and

WHEREAS, funds are available in the Equipment (Capital) accounting line item in the full amount and same have been certified by the Certifying Officer


